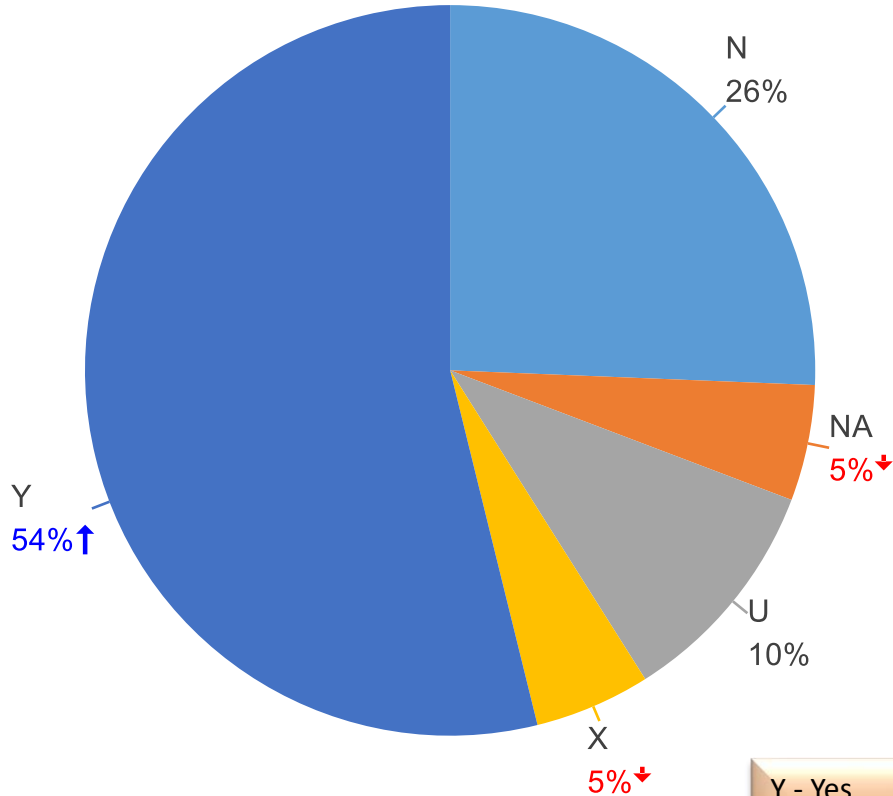

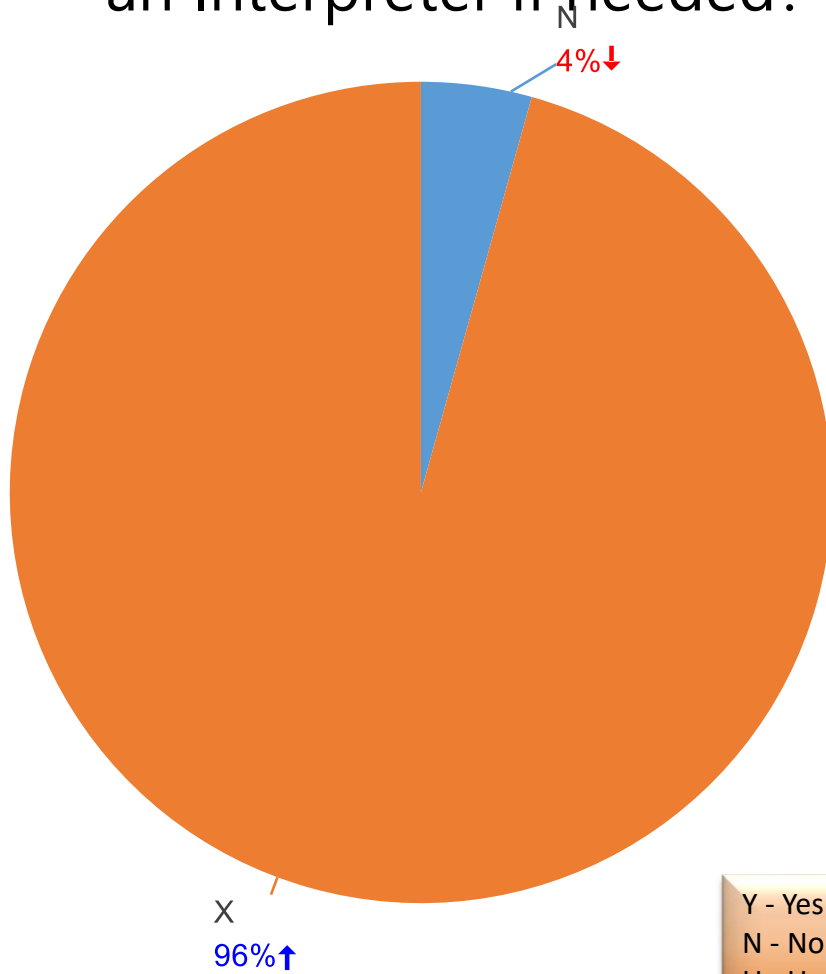


Was the Respondent represented by an Attorney?

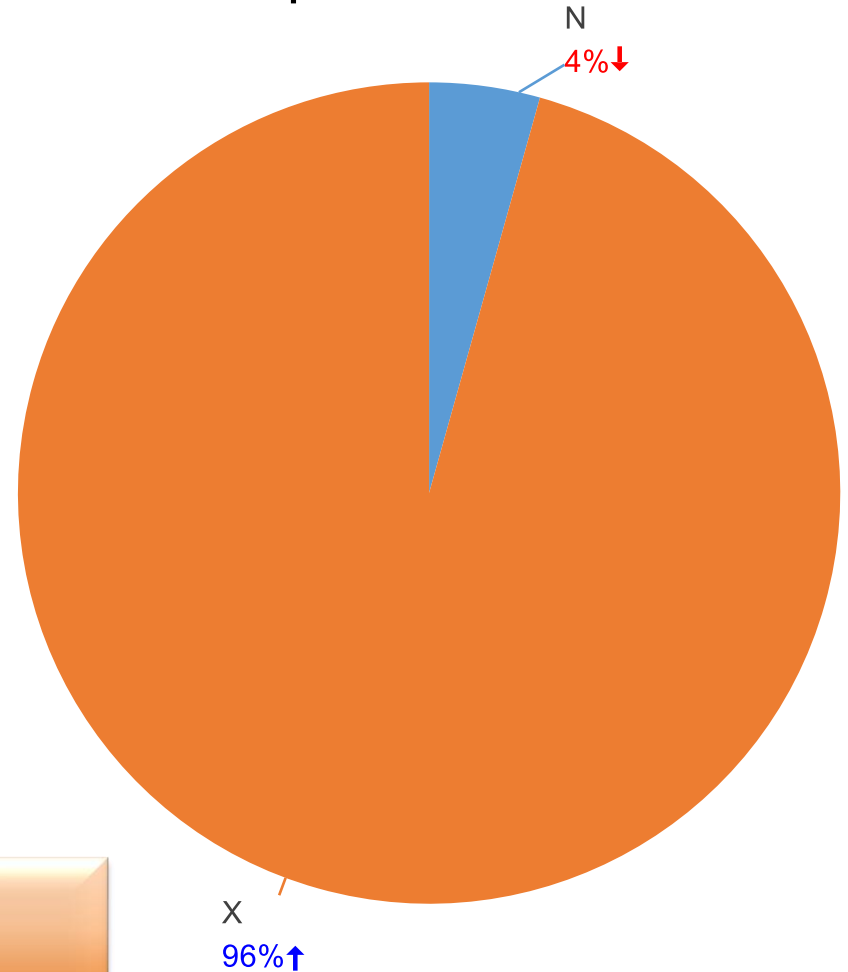

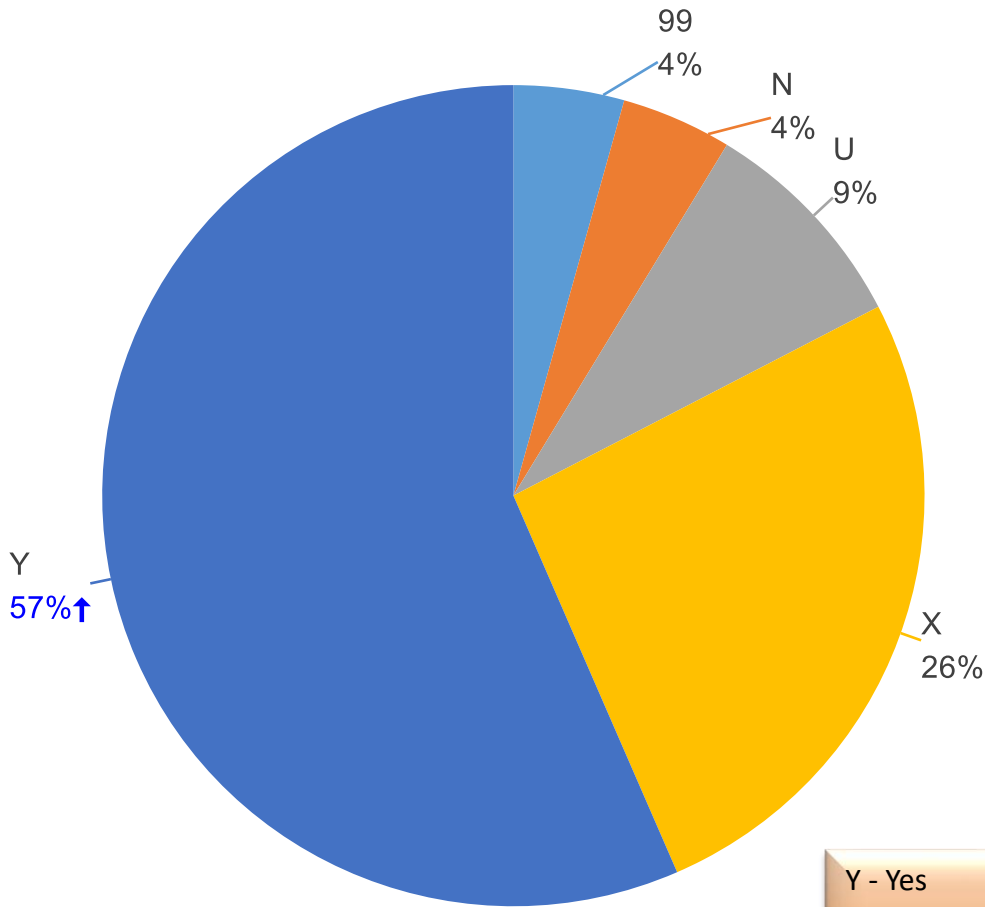

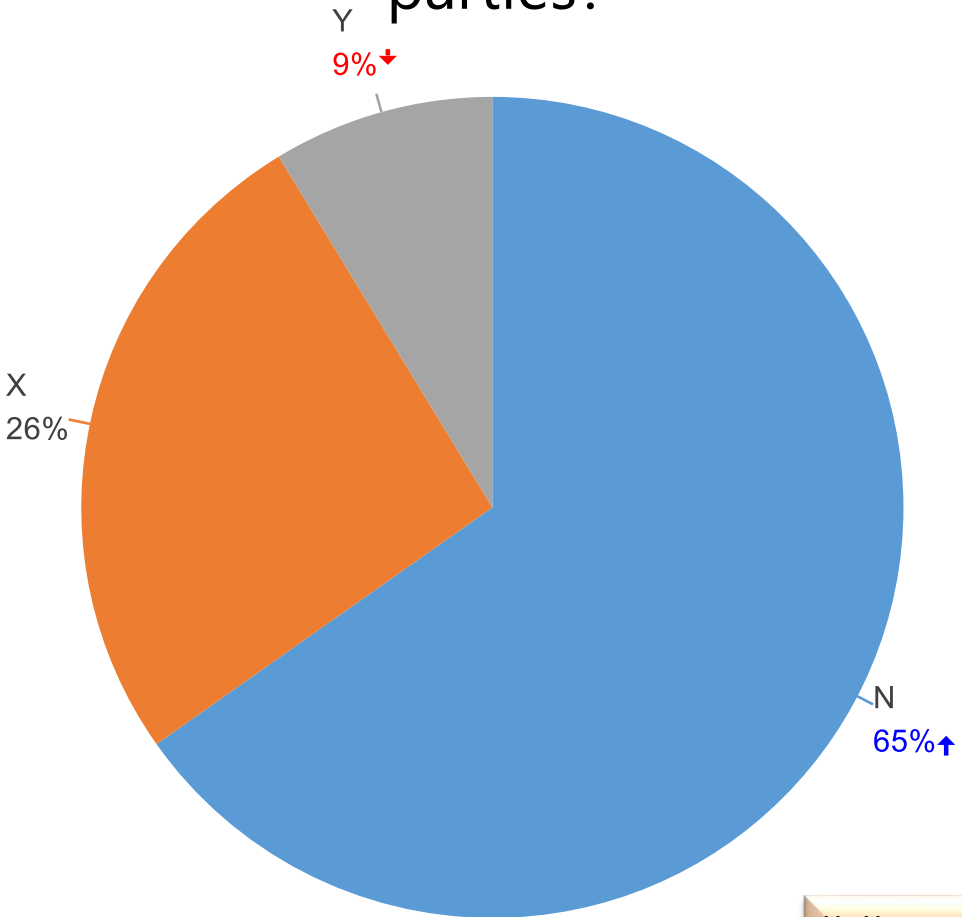
